



CANINE SURRENDER AGREEMENT

I, _____ (18 years or older), do hereby voluntarily and **irrevocably** give, donate, surrender and release to Gray Face Acres hereinafter referred to as "GFA", the following dog(s), hereinafter referred to collectively as "Dog(s)".

_____ (Please initial) I further acknowledge that I am releasing the Dog(s) completely voluntarily and that no representations, considerations or promises of any kind have been made to me by GFA or any of its representatives.

I understand that by releasing the Dog(s) to GFA, I relinquish all ownership or other interest in the Dog(s). I hereby release and forever discharge GFA from any and all rights, claims, obligations, liabilities, and causes of action whatsoever arising out of or relating to the ownership, possession, or disposition of the Dog(s), and I agree to indemnify and hold harmless GFA from and against any and all such rights, claims, obligations, liabilities, and causes of action which may be asserted by third parties.
